What's Next?

After your parish group finished the Beyond the Boundaries Discussion Series, were there questions on what to do next? Groups report the dialogue helped develop relationships based on mutual interests, shared experiences, and trust. Their discussions heightened awareness of issues and the principles of our faith, energizing people with a keen desire to make a positive difference.

But, the issues can seem so broad, intertwined, and <u>overwhelming</u>, that it's difficult to know where or how to start. A challenge we face is to be fully aware of the injustices that God calls to our attention and to accept the grace to collaboratively develop and implement strategies to change inequities.

The best way to progress is to develop a plan. This plan does not need unique solutions. It often works better if

groups can join in current efforts, capitalizing on the talents of members.

Sometimes a bigger task than addressing the issues is to determine what we can do—both individually and collectively—to take action to change injustices in our community.

What talents and expertise are available among members of the BtB Discussion group, parish, or community? The strength of the group depends on each person's willingness to contribute their skills, even going beyond their comfort zone, to work for positive change.

What potential solutions did your group identify? Are these ideas an outgrowth of a collaboration for a more realistic approach and outcome?

A clear purpose, coupled with a willingness to go beyond our own boundaries, to work collaboratively reflecting diversity, is key for each group's success.

Affordable housing in mixed-income neighborhoods, the top priority of most participants and a basic necessity, is the key focus for Beyond the Boundaries. Education, jobs, fair wages, transportation, and other interdependent areas are also vital for providing equitable opportunities.

BtB groups throughout the region join together to advocate for equitable policies and practices within jurisdictions, and at state and federal levels. Groups also undertake a variety of advocacy work within their local area, working with other faith or community groups. These coalitions, based on mutual interests, yield more effective results with decision makers. (See "BtB Parish Groups" for examples of group activities.)

Beyond the Boundaries' role is to link participants with advocacy opportunities to address causes of injustice.

The devastation caused by the hurricanes certainly underscored the disparity in our society. More than ever, the effects of concentrated poverty are brought into focus. People wonder how and why poor people are in such vulnerable positions. Perhaps the question is why were we not concerned even before the storm damage flashed this disparity on the news?

Decades of policies led to economic and social segregation with poor people concentrated in deprived areas. We don't have to travel far to see it first hand. Baltimore ranks 13th highest of the fifty largest cities in the U.S. with a 22.7% rate of concentrated poverty. Thirty neighborhoods are "extreme poverty neighborhoods" where 40% of the population are below the federal poverty threshold (\$19,158 for four people), per the just-released Brookings Institute report. Can you imagine living on \$19,158 for even one person?

Let's use this stark situation to reinforce our determination to work for neighborhoods of choice and connection, rather than relocating concentrations of poverty. "Communities of choice in which people of lower incomes can find a place to start and, as their incomes rise, a place to stay. They are also communities to which people of higher incomes can move, for their amenities, location, and housing value. Neighborhoods of connection link families to opportunities...good schools...and good jobs." as described in the Brookings Institute report; October 2005.

House Keys 4 Employees is

a new program intended to help Maryland workers purchase a home in this state. Eligible homebuyers may receive a zero percent deferred loan of up to \$5000, matching participating employer's \$5000 contribution, towards a down payment and closing costs.

Churches without Boundaries was

formed by the BtB Core Group from St. Mary's, Annapolis as an inclusive coalition of faith representatives who collaborate to raise awareness and change systemic injustices in the Greater Annapolis area. CwB brings together over a dozen faith groups in this diverse, inclusive coalition.

Committees were formed to address issues most important to the members. These are: Affordable Housing, Education, Health Care, Substance Abuse Prevention and Treatment, and Youth Recreation Committees.

Committees develop advocacy strategies and engage all members who, in turn, engage their respective, diverse faith communities to promote justice. This method broadens support for a more effective coalition.

Members and their faith groups played a significant role in the passage of Inclusionary Zoning legislation for the City of Annapolis—a major accomplishment! CwB, along with BtB leaders, led the Workforce Housing Coalition for legislation in Anne Arundel County. Members and their churches were actively involved in advocacy for affordable housing with letter campaigns, meeting with public officials, attending hearings, and testifying. The CwB Housing Committee continues to build understanding of the need for affordable housing advocacy, preparing for the next legislative effort. (The next Housing Committee meeting will be held in early November. Call 443/623-1355 for details.)

Each committee has notable successes in advocating for just practices and policies. CwB continues to grow and exert influence for the best interest of all in the community.
